To the Honorable Judge of Said Court-

PHHxx (all companies in The Family) and USDOJ have endorsed this supplemental agreement with Dave McCrae in full settlement of all open claims and contentious issues. No further civil or criminal persecution of PHHxx will proceed.

PHHxx will recompense the United States Department of Justice USD500,000,000, immediately on execution of this agreement, as restitution and penalty, to be distributed as designated solely by USAG. PHHxx will immediately abjure, repudiate and discontinue these unsavory practices of record.

PHHxx and Mr. McCrae will mutually agree and designate 5,000 properties from it's REO portfolio to be transferred to Mr. McCrae or his designees, unencumbered, said transfer to be recorded in each state separately and individually as is customary. These properties, land and structures, will be valued at \$1,000/each for bookkeeping purpose under GAAP. All properties are assumed as is, where is, with no warranty. All taxes and transfer costs will be borne by PHH. See SCHEDULE A attached.

PHHxx will acquire and refit the good ship WHY, currently documented and berthed in New Zealand, including hull inspection and repair, new sails and rigging, -0- time engine, generator, new furnishings, galley, watermaking, and navigation and communications package, and turn over to Mr. McCrae at completion within one year of this agreement. A reserve account of USD2,500,000 will be established as an escrow account under the sole administration and direction of Mr. McCrae, with any remaining funds transferred to Mr. McCrae on launch, successful sea trial, and turnover at dockside.

PHHxx will immediately pay usual, customary and reasonable fees to Mr. McCrae, as earned at 1 bitcoin per day from 11/1/2012, the initiation of our discontent, through the effective date of this consent judgment issued by the Court.

May God bless this agreement and undertaking, and continue His Good Favor to all, and all go their separate ways from this time forward, and Make America Great Again.
